But spring will come and ACEC/MD continues to push our 2010 Legislative Business Agenda during the Maryland Legislative session. As you are aware, the focus of the 2010 agenda is infrastructure funding, as well as four other very important initiatives including STEM Education, prohibiting indemnifying another party for their negligence, Minority and Small Business subcontracting and Qualifications-Based Selection. We need the help of our member firms and their employees to get the word out to our legislators so they understand our concerns and positions on these key issues. On January 21, 2010, we held our annual Legislative Action Day in Annapolis where we



sponsored a buffet lunch at the Governor Calvert House, a short walk from the House and Senate Office Buildings. Over 75 General Assembly members joined ACEC/MD members for lunch, which provided the perfect opportunity to discuss our critical issues and promote our business agenda. ing is so very important to improve the current economic conditions in Maryland. Our visits and luncheon were very successful in reaching a large number of legislators and providing a casual forum to communicate. While they generally agreed with our initiatives regarding transportation and infrastructure funding, not surprisingly they also acknowledged that an increase in the gas tax is unlikely to occur in 2010 considering it is an election year. Regardless of the timing, ACEC/MD must keep the pressure on to solve this funding crisis.

Similar to our meetings in Annapolis, a group of ACEC/MD members traveled to Washington D.C. on February 4th and met with several senators and congressmen to discuss the current Jobs Bill proposal and the need to include planning and engineering in the proposed transportation and infrastructure funding. Most of the legislators and their staffs were receptive to our recommendations.

The Maryland Legislative Session is in full swing and bills are being filed almost daily, resulting in almost 2,400 pieces of legislation. Your ACEC/MD Legislative Committee has been meeting weekly, reviewing these bills and determining a course of action for each bill that

potentially impacts our profession. These actions typically consist of supporting or opposing legislation through testimony or written correspondence, monitoring or taking no action. I want to personally thank Jim Blake, the Legislative Committee Chair and the entire committee for their hard work and dedication to ACEC/MD in performing this critical function. That being said, there is much work ahead and when a request is made to contact your legislator in support or opposition to a particular bill; please take the time to write, call and/or email your senator or delegate to express your recommendations.

ACEC celebrated "National Engineers Week" during the week of February 14th by promoting engineering nationwide. Here in Maryland, ACEC/MD held our annual awards banquet on Thursday, February 18th at the Engineering Society of Baltimore in the Garrett-Jacobs Mansion. The banquet was well attended and we presented the Engineering Excellence Awards for outstanding projects; recognized individuals for outstanding service to our profession and community; and awarded two ACEC/MD Scholarships and the Kahl Scholarship to deserving engineering students.

Congratulations to the award winners for their dedication and service to the engineering profession.

The ACEC Annual Conference and Legislative Summit is scheduled for April 25th to April 28th in Washington, D.C. at the Grand Hyatt Hotel. The focus of this conference and summit is current legislative issues impacting the consulting engineering profession including transportation and water infrastructure funding, lobbying your Senators and Congressmen; networking with fellow principals from all 50 states; and entertaining sessions including commentators Patrick Buchanan, Eleanor Clift and Greg Ip. PAST PRESIDENT STEPHEN RECOGNIZED AS ACEC/MD'S NEWEST FELLOW

ACEC/MD's December General Membership Meeting was once again hosted by the ACEC/MD's Fellows Committee. Highlighting the meeting was the recognition of ACEC/MD's newest Fellow Harry Stephen (Century Engineering).

Harry Stephen, PE, is a Senior Vice President and a member of the Executive Committee of Century Engineering at their corporate office in Hunt Valley. Harry has over 35 years of experience in transportation projects throughout Maryland including planning, design and project management.

A resident of Fallston in Harford County, Harry graduated from the University of Delaware in 1973 with a Bachelors of Civil Engineering degree specializing in Transportation and Urban Planning, and has been a registered professional engineer in Maryland since 1978. Harry joined Century in 2002 and was promoted to a Senior Vice President responsible for the Transportation Division of Century Engineering in Maryland. In 2008 his responsibilities were expanded to include the management of Transportation for all offices of Century Engineering.

In addition to serving as an ACEC/MD Director, in all the ACEC/MD officer positions, including President in 2008-2009, and as the chair of ACEC/MD's Membership Committee, Harry currently serves ACEC/MD as ACEC Alternate Director.

MDOT MBE DIRECTOR DISCUSSES GRADUATION AND NAICS CODES

At a recent meeting with MDOT MBE Director Zenita Hurley and MDOT MBE Chief Procurement Officer Carmina Perez-Fowler, ACEC/MD SBE Committee representatives presented a range of questions addressing topics such as graduation from the state's MBE program and NAICS Codes. For your information, the following notes from this meeting are as follows:

Meeting Notes

In Attendance: Zenita Hurley (Director, MDOT MBE), Carmina Perez-Fowler (Chief Procurement Officer, MDOT), Ziad Sabra (ACEC/MD), Bev Pannee (ACEC/MD), and Jim Otradovec (ACEC/MD).

MDOT representatives expressed concern about identifying the specific NAICS codes for MBE/DBE participation as part of the solicitations because they think not including the NAICS codes gives prime contractors more flexibility in soliciting the services of a wide variety of MBEs. MDOT will be sending out letters to MBE firms asking them to review the current certification information with MDOT, and also encourage them to consider certifying for other services if they have the resources and expertise. So that Prime Consultants find it easier to recognize the qualified services, Ms. Hurley suggested that they may consider adding a list of "subcontracting opportunities" in the solicitations to clarify the services that correspond to the various pertinent codes. She noted that MBE firms should tell Prime Consultants what services they are qualified for and if the Prime Consultants still have questions, then they should call the MDOT MBE Office.

Service/NAICS Graduation and retainage of backlog On Federal and State contracts, a DBE/MBE firm is allowed to retain all awarded backlog after graduation and the prime will get credit for all work done even after DBE/MBE graduates from a specific service (as long as the firm graduated after contract award). However, although the work is retained, the State will not get credit toward the Federal Program after a DBE firm graduates.

MBE Goal Credit: DBE firms that pursue prime work on Federal contracts can get the full credit for all self-performed DBE billings (beyond the contract goal) and MDOT also gets full credit for all DBE dollars billed. However, on State-funded only contracts, an MBE prime firm can not get any credit toward meeting the MBE goal of the contract, but SHA does get credit in its program for all dollars billed by the Prime MBE firm.

Graduation from NAICS Code

Services: Firms that graduate from a specific NAICS code before a contract is signed and awarded by the State can not participate on those specific services. However, these firms can participate in work related to other NAICS non-graduated codes. For example, graduating from engineering design services does not prevent an MBE firm from doing highway and bridge inspection services. A DBE/MBE firm should advise the prime contractors of all services for which they are MDOT certified and are not in graduated status.

Key Staff from Graduated Firm: What happens when Prime Consultant is selected for a contract and they use a Key Staff from an MBE firm, but the MBE firm has graduated from their provided services under that contract before the contract is signed and awarded? In this case, MDOT requires the Prime Consultant to retain the MBE firm and to provide those services even if they don't get the credit for the MBE work. This is due to the fact that the decision was made based on the Key Staff, and changing the key staff could jeopardize the contract from going forward.

Ownership Transition: Ms. Hurley suggested that MDOT will work with MBE firms who are transitioning to new ownership. In order for a firm to improve its chances of transitioning to new minority ownership without a break in its MBE certification, firms should first promptly notify the MDOT MBE Office of the change. Once a firm notifies the MDOT MBE Office that there is a change in Ownership, then MDOT will issue a letter to the MBE firm advising them that their MBE status will no longer be eligible under the old

ownership. Subsequently, the old Firm needs to appeal the decision, and quickly submit a new application for MBE Certification under the new Ownership. (Note that the new owners must meet MBE certification requirements (that is not only being minorities, but also economically disadvantaged and also have the right fiscal, operations and technical control of the new operation). MDOT will, within 3 months or so, review the new application and make a decision on the certification eligibility. During the appeals process, the MBE Firm remains certified and can continue to do business as usual until a final decision is made. However, the MBE firm should not make any promises to the new Owners until MDOT makes the final decision. Ms. Hurley confirmed that her office's goal is to help the MBE firms succeed in operations and in transitions to new minority owners as well, and will exercise all possible means within the law to make sure the goal is achieved.

Future Matchmaker Program: Ms. Hurley said the continuation of this program will depend on the needs of the engineering companies and organizations and has to be driven by them. Ms. Pannee discussed past successful experiences with the program. Ms. Hurley showed great support for continuing

this program and she offered the MDOT HQ

Office as the meeting place.

With approximately 1/3 of ACEC/MD firms either registered small-or minority-businesses in the state of Maryland, ACEC's SBE Committee, chaired by Sabra, Wang & Associates' Ziad Sabra, continues to address a myriad of issues impacting many of our member firms. The committee is in the process of working with MDOT to develop a matchmaker program scheduled for June 16, 2010. This program will feature valuable workshops and targeted appointments with prime firm representatives. Small firms are encouraged to get involved with this committee.

ACEC/MD ONCE AGAIN ACHIEVES ACEC/PAC GOAL

SCHNABEL'S JEFF NELSON WINS TOP PRIZE IN RAFFLE

Thanks to the strong support of ACEC/MD member firm representatives and lead by 2009 ACEC/MD ACEC/PAC Champion George Wirth (Schnabel Engineering), ACEC/MD was once again able to achieve its ACEC/PAC federal fundraising goal. Due to your efforts, ACEC/MD raised over \$18,000 to assist ACEC in its goal to be a \$1M per year PAC, placing the organization in the top 4% of PACs in the United States. ACEC/MD was one of 29 states that met or exceeded their 2009 goal. Nationally, 1,800 ACEC/PAC supporters propelled ACEC/PAC to new heights, raising \$573,000 in 2009, a record for a non-election year.

In order to achieve the ACEC/PAC goal, ACEC/MD's Executive Committee authorized a raffle with proceeds going to the Federal PAC. Schnabel Engineering's Jeff Nelson was the winner of the \$1,500 Grand Prize, while Jack Moeller (Johnson, Mirmiran & Thompson) and Art Ebersberger (CBIZ) took home Second Place prizes of \$500 each, and Rick Smulovitz (Johnson, Mirmiran & Thompson) won Third Place in the amount of \$300.

Reflecting ACEC's political strength in electing bipartisan pro-business members of Congress, the following accomplishments occurred in 2009:

- House passage and Senate committee passage of a multi-year water infrastructure bill that boosts funding water projects and expands QBS.
- House passage of an aviation reauthorization bill that expands funding and broadens the application of QBS.
- An economic stimulus program that included \$130-billion in new infrastructure investments.
- A House-passed jobs bill that sets aside an additional \$50-billion for infrastructure.
- Successful conclusion to the US DOT OIG audit and the corresponding AASHTO Audit Guide update.
- New building code requirements in pending House and Senate energy legislation that will create opportunities for mechanical/electrical firms.

ACEC was also successful in confronting a number of business challenges, including mandates in pending health care proposals and another union agenda seeking to curtail contracting out.

Of course 2010 will present another set of challenges to your business and the complexities of an election year. Over the past 17-midterm elections, the sitting President's party has lost an average of 28 seats in the House, and an average of four seats in the Senate. Add to this the 27 open seats in the House and the ten current seats in the Senate and you have a Congress in flux.

With your support, ACEC/PAC will have a tremendous opportunity to influence several key Congressional elections. Your continued contributions and encouragement of the support by colleagues in the industry will help to shape the business climate for years to come.

RETIRED WBCM PRESIDENT DAVID MONGAN NOMINATED TO PE BOARD

Acting on ACEC/MD's recommendation, Governor Martin O'Malley has nominated David G. Mongan, P.E., F. ASCE, to a civil engineer position on the Maryland State Board for Professional Engineers. He will replace Eugene Harvey, P.E., who has resigned from the Board.

David recently retired as president of Whitney, Bailey, Cox & Magnani, LLC, and is immediate past president of the American Society of Civil Engineers. He has 36 years of experience in civil engineering.
