President's Message by Joe Makar, P.E.



The Legislative Session is in full swing and ACEC/MD, with a group of organizations and businesses, developed an alliance that is known as "START" (Statewide Transportation Alliance to Restore the Trust). This alliance, led by several major organizations including AAA, the Greater Baltimore Committee, the Greater Washington Board of Trade and the Maryland Chamber of Commerce, committed to working with the Governor and General Assembly to enhance transportation in Maryland by reducing congestion and improving safety. The key components of the alliance's goals include

increasing the funding to the Transportation Trust Fund and sparing the Trust Fund from any further raids by enacting legal protections for the Fund.

The Governor's "Blue Ribbon Commission on Maryland Transportation Funding" is also moving along in reviewing the status of transportation issues in Maryland, and in the near future will make recommendations concerning State transportation funding sources and the Maryland Transportation Trust Fund.

Senator Robert J. Garagiola submitted a bill on transportation funding, which includes increasing transportation funding and protection of the Transportation Trust Fund. Senate Bill 714 was submitted on February 4th. ACEC/MD strongly recommends that you call your local legislators and let them know you are in favor of this bill. In this "no tax" climate it is important that your legislators hear from you in order for this bill to have a chance of passing.

In order to have the opportunity to support our local legislators that have championed infrastructure investment and to explain our position on issues that are important to our industry, it is imperative that we contribute to CEPAC, which is ACEC/MD's State Political Action Committee. Through both your financial support and grassroots lobbying efforts, we can make a difference.

SHA Partnering Meeting: On February 10, 2011 SHA met with ACEC/MD to discuss numerous topics that impact our industry. We discussed the status of the CTP, Reauthorization, FAR, On-site Consultant Training Policy and the contract expiration/extension issue. One of the major topics that will impact many of our member firms is the Reauthorization from the Federal

level. It appears that there is no positive movement to develop a reauthorization bill to meet the needs of our aging infrastructure. We will keep you posted on the status.

Awards Banquet: I congratulate all the winners in this year's competition. The variety of projects and the individual contributions spotlighted during this gala evening personify the positive contributions that our member firms make to society on a daily basis. Legislative Alert: Transportation Trust Fund Support

Celebrate 2011 National Engineers Week

February 21-25

We need your help in urging Maryland's legislators to address the dangerous state of Maryland's transportation funding and to follow the recommendations just issued by the Blue Ribbon Commission on Transportation Funding. It is absolutely critical that you and your employees contact members of the Maryland Legislature and urge them to vote in favor of *House Bill 1001 and Senate Bill 714 - Transportation Trust Fund – Financing – Use of Funds*. House Bill 1001 and Senate Bill 714 have hearings scheduled in the House Ways & Means Committee on March 1st and the Senate Budget & Taxation Committee on March 9th.

If your/their elected officials are not on the committees that are considering the legislation, please suggest that they encourage members of the House Ways & Means Committee and the Senate Budget & Taxation Committee to support these bills.

Key features of the Legislation:

- Constitutional Amendment protecting the Transportation Trust Fund (TTF) from further use as a general budget fund
- Ten-cent increase in the fuel tax effective July 1, 2011
- One-cent maximum annual increase in fuel tax beginning 2013 indexed to the construction cost index (CCI)
- 50% increase in the annual vehicle registration fee

The provisions in this legislation are consistent with the findings of the Blue Ribbon Commission on Maryland Transportation Funding that identifies the fiscal crisis facing the state of Maryland.

Data presented to the Commission highlights that a ten-cent per gallon gas tax increase costs only an average \$58 per vehicle per year. Contrast this fact with the national transportation research group TRIP's study that reveals that the condition of Maryland's transportation system is costing the average motorist \$2,300 each year, as commerce and commuting are constrained by traffic congestion on Maryland's roads. Coupled with the recent findings by the Texas Transportation Institute that ranked the Washington, DC area and Baltimore area as the worst and fifth most

congested area in our nation, respectively, requires that action be taken immediately.

With toll increases on the horizon in the fall, it is imperative that the 6,000 employees of our member firms contact their elected officials today.

Utilizing the following <u>sample</u> letter, please contact both the elected officials representing your residence and the district that your firm is located in. To locate the appropriate legislative district, please go to the Legislative Action Center of ACEC/MD's website (<u>www.acecmd.org</u>). And don't forget to utilize the "Transportation and You" presentation, also located on the website, as a resource for informing employees about funding transportation projects in the state.

As a resident of the (<u>insert District</u>) and an employee of (<u>insert firm name</u>) that employs (<u>insert number of people</u>), I respectfully request that you encourage the members of the House Ways & Means Committee / Senate Budget & Taxation Committee to act favorably on HB 1001 / SB 714 – Transportation Trust Fund – Financing – Use of Funds.

In addition to ensuring through a constitutional amendment that funds in the Transportation Trust Fund are used only for purposes relating to transportation except for defense or relief purposes, this legislation provides for a:

- Ten-cent increase in the fuel tax effective July 1, 2011
- One-cent maximum annual increase in fuel tax beginning 2013 indexed to the construction cost index (CCI)
- 50% increase in the annual vehicle registration fee

This legislation is consistent with the findings of the Blue Ribbon Commission on Maryland Transportation Funding that Maryland's transportation system is facing a fiscal crisis. Additional investment in our transportation system will create jobs, ensure safe travel, reduce travel time, and provide for the quality of life that your constituents expect.

Data presented to the Commission highlights that a ten-cent per gallon gas tax increase costs only an average \$58 per vehicle per year. Contrast this fact with the national transportation research group TRIP's study that reveals that the condition of Maryland's transportation system is costing the average motorist \$2,300 each year, as commerce and commuting are constrained by traffic congestion on Maryland's roads. Coupled with the recent findings by the Texas Transportation Institute that ranked the Washington, DC area and Baltimore area as the worst and fifth most congested area in our nation, respectively, requires that action be taken immediately.

In order for this funding increase to gain support the integrity of the Transportation Trust Fund must be maintained.

There is a real cost for inaction on this important matter, therefore, I respectfully request that you vote favorably on this important legislation.

SHA / ACEC/MD Partnering Committee Addresses Contract Extension Issue

One of the most important issues addressed at the February 10th SHA / ACEC/MD partnering meeting was the negative impact of the Board of Public Works Advisory issued February 18, 2009 that eliminates contract extensions. With the downturn in the economy and the resulting diminished utilization of many MDOT contracts, agreements are expiring with millions of unallocated dollars remaining that could be used on future projects.

Section 7 of BPW Advisory No: 1995-1 states that:

Modifications to extend a contract term are permitted only if extended before the term expires and:

- (a) The purpose is to:
 - Complete work under a task order issued before the contract expires;

Or

- (2) Provide the State agency a reasonable, limited, and defined time to complete the new procurement, to resolve a protect, or to facilitate a successful transition between contractors; or
- (b) When there are unspent funds remaining, an agency may extend a contract but not add funds (no-cost extension) for a reasonable limited, and defined time if the:
 - (1) Original contract contains a provision authorizing the no-cost extension;
 - (2) Approved Action Agenda Item stated that the contract contained a provision authorizing a no-cost extension;
 - (3) Scope of work under the extension is the same as the original contract;
 - (4) Agency provides prior written notice to the board of its intent to extend the contract the extension terms.

Board regulations concerning the approval of Action Agenda Items or the reporting of PAARs must be complied with.

The decision is not only costing the state, but is a tremendous financial drain on our firms including many small and disadvantaged businesses.

MDOT Chair Frank Waesche (Wallace, Montgomery & Associates) is in the process of once again contacting MDOT Secretary Swaim-Staley to advise her that our predictions on the impact of this advisory are coming to fruition.

ACEC/MD representatives will then approach representatives of the Board of Public Works to explain that their well-intentioned action to increase competition is costing both the state and our firms a tremendous amount of money.

Thank You for Helping ACEC/PAC be the Top Engineering Political Action Committee in the Nation

By raising \$20,713 and eclipsing its goal, ACEC/MD was one of 30 states that achieved their 2010 ACEC/PAC goal. In total ACEC raised \$580,000, placing the PAC in the top 4% of all PACs in the nation.

Our work is far from done with important issues such as infrastructure reauthorization, and repeal of the onerous 3% withholding tax and 1099 mandate at the forefront.

In order to achieve the goal of ACEC/PAC becoming a \$1-million PAC, ACEC/MD's goal has been increased to \$21,470.

The aforementioned mandates are due to kick in in 2012. Sponsors are lined up for repeal legislation. In order to continue the positive momentum we are seeing on these and other issues, we will once again need your support. Maryland's Congressional Delegation Voices Support for ACEC-Backed Initiatives ACEC/MD Congressional Visits Set for March 30th

We are pleased to report that a major theme at the 2011 Maryland Chamber of Committee Congressional Dinner was increasing infrastructure funding and encouraging job creation.

Seven of the ten Maryland Congressional Representatives participated in this town hall style meeting, addressing issues of importance such as the economy, transportation funding, and business and environmental regulations.

Following up on this theme, ACEC/MD received a letter from Congressman C. A. Dutch Ruppersberger that included a copy of a correspondence from several members of Congress to Speaker of the House John Boehner and Democratic Leader Nancy Pelosi. The letter encourage House Leaders to resist efforts to cut transportation funding when considering proposals to cut federal spending across the board.

In addition to Congressman Ruppersberger, signing on to this letter from Maryland were Congressional Representatives Donna Edwards and Elijah Cummings.

Also contained in the correspondence was a request to quickly bring to the floor bipartisan legislation to reauthorize the surface transportation programs. The letter cited the strong link between infrastructure programs and the creation of jobs. For example, every \$1-billion invested in transportation infrastructure creates about 35,000 jobs and adds up to \$6-billion to the Country's gross domestic product.

Maryland Senator Ben Cardin was also at the forefront in supporting ACEC's efforts to repeal the burdensome 1099 reporting requirement that was part of the federal health care law. The Senator was part of a strong majority that voted 81-17 to repeal the requirement that, commencing in 2012, would require firms to file a 1099 for every vendor that sells more than \$600 in goods. Unfortunately, Senator Barbara Mikulski voted against repeal.

Included in the Federal Aviation Amendment, once passed by the entire Senate, the repeal measure would move to the House as HR4. Included in the 263 House sponsors are Representatives Roscoe Bartlett, Andy Harris, and Dutch Ruppersberger.

Be sure to mark your calendars, and plan to join other ACEC/MD members on Wednesday, March 30th as we hit Capitol Hill as part of ACEC's Annual Legislative Summit. ACEC will provide position statements on their website and conduct an issues briefing that morning for the 2011 ACEC Annual Convention registrants. While attendance at the convention is encouraged, it is not mandatory to participate in the visitations.
