PRESIDENT'S MESSAGE by Jack Moeller, P.E.



If you are tired of the cold weather and snow how about some Maryland politics to warm you up?

It is still too early to tell how we will fare during this legislative session, but we appear to be on track with our legislative agenda. Bills have been introduced addressing our legislative agenda items including:

- HB 345 Courts Certificate of Merit Provider of Professional Services
- HB 1302 Agreements to Defend or Pay the Cost of Defense - Void
- HB 1315 Minority Business Participation Liquidated Damages Provisions Exclusion for Architec-

tural and Engineering Services Contracts

Our Legislative Committee continues to testify on these bills when the hearings are scheduled. They are also ready to provide written and oral testimony on the numerous bills attempting to defund previously passed environmental infrastructure funding. Because this is an election year, we need to be vigilant until the bell rings at midnight April 7th, sine die.

It is never too early to start thinking about next year. I recently attended the ethics training at the MDQI annual conference given by Mr. Michael Lord, ESQ, Executive Director of the State Ethics Commission. While much of the training focused on the dos and don'ts of dealing with State employees, I found two issues to be particularly eye opening. The first is that the Ethics Commission recognizes that the existing ethics law doesn't really fit the current procurement methods for Design/Build or P3s. The second issue, after prodding by me, is that Mr. Lord would support moving Article 15-508 from the State Government Article to the State Finance and Procurement Article. So, why is that important?

The simple answer is that Article 15-508 deals with procurement and belongs in

the State Finance and Procurement Article not in the State Government Article that deals primarily with State government operations. Again, so why is that important? Currently if there is a question about anything pertaining to Article 15-508 the State Ethics Commission has sole jurisdiction. The procurement officer, the agency head and the Board of Contract Appeals, which are typically involved in

other contract matters and disputes have no say so. Routine decisions that could easily be answered by the procurement officer now are referred to the State Ethics Commission. The Ethics Commission's structure and operating procedures are not designed to provide quick responses on complicated procurement matters. It is designed to be a deliberative process to essentially determine the guilt or innocence of a State employee or official. While it does have a small staff to perform investigations of alleged ethics violations, it does not have expertise in procurement methods, design or construction. Another complication is that the Ethics Commission is required by statute to keep all of its decisions confidential unless the individual or company requesting advice gives their approval to release the decision. Therefore, decisions that could affect the viability of subconsultants or primes on a contract could be hidden from the rest of the team. The obvious result could be rejection of the entire team, including the innocent members, on a project.

A couple of examples might better illustrate my concerns:

Example No.1

XY Consulting worked on the preliminary design and developed the procurement specifications for a Design/Build (D/B) transit project. XY performed \$700K as a DBE subconsultant on the job. XY asks the State Ethics Commission for an advisory opinion on whether it would be precluded from participating on the final D/B project. XY is advised by the Commission in a confidential opinion that it could not participate because it performed over \$500K of design and drafted the specifications. XY decides that it doesn't agree with the Commission and proceeds to join a D/B team. The team submits a Statement of Qualifications and is found to be non responsive by the transit agency because of XY's initial work on the project. The D/B team had no way of knowing of the Commission's opinion because it was confidential and the transit agency took no responsibility for the completeness of the list of precluded firms.

Example No.2

YZ Consulting worked on the preliminary design for a D/B transit project. YZ performed \$400K as a DBE subconsultant on the job. The transit agency incorrectly listed YZ in the procurement documents as a firm precluded from participating on the project. YZ files a protest which is rejected because YZ's only recourse is to request an opinion from the State Ethics Commission. The D/B team decides it can't wait six months for the Ethics Commission to make a decision and selects a different subconsultant.

So let's go back to the first issue, the current ethics law doesn't accommodate D/B or P3 procurements very well. Since Article 15-508 is the only section of the Ethics law that covers procurement, moving it to State Finance and Procurement Article would solve the problem. The Finance and Procurement Article has the necessary supporting language, definitions and procurement regulations (COMAR Title 21). Presumably, Article 15-508 is poorly understood because it is orphaned from the rest of State procurement law.





PRESIDENT'S MESSAGE (continued)

While we are too late to make changes this year, I believe we should make this high on next year's legislative agenda. The ideal method would be to work with the Administration through MDOT, DGS and the Ethics Commission to craft legislation that would be introduced as a departmental bill.

Now for an update on our short term goals for the year:

- 1. We have met our goal of adding three new regular members and one affiliate member.
- 2. We didn't meet our goal of having at least 100 member employees attend the annual legislative luncheon. Only 56 members attended and we were outnumbered by the 87 legislators and aides that attended. We need to do better next year.
- 3. We are on target to meet our goal of having a program targeted for MEP firms. A program on the Education Market is scheduled for March 25th.
- 4. We met the goal of having a scorecard for ACEC/PAC, CEPAC and Minuteman fund raising.
- 5. Our goal of timely dues payments is improving. Seventeen of the 21 firms that represent the Executive Committee and Committee Chairs paid their dues by December 31st.
- 6. We are still working to meet our goal of clarifying the official representative and alternate for each member firm. If you haven't already done so, please update your contacts.

Lastly, please be prepared to respond to "Legislative Alerts". With over a month remaining in this election year legislative session, there will be a need for us to mobilize at least 1000 employees to send emails and letters to their legislators in support of our agenda.

ACEC/MD REPRESENTATIVES PROMOTE BUSINESS AGENDA

Kicking off a very active legislative session, on January 16th, over 55 ACEC/MD representatives took time out of their busy schedules to participate in this year's Legislative Action Day.

First on the agenda were meetings in the morning with key elected officials to discuss ACEC/MD's primary initiatives for 2014. This was followed by an informal luncheon at the Governor Calvert House, where 86 legislators and their aides were provided the chance to sit down with their constituents prior to the upcoming elections. The day's activities laid the ground work for more extensive efforts in support of ACEC/MD's legislative initiatives.

While legislators appear to appreciate the unintentional consequences associated with the liquidated damages provision for MBE compliance, there is always hesitation for them to support any initiative that is perceived as eroding the MBE laws in the state. A hearing on House Bill 1315 is scheduled March 3rd in the House Health and Government Operations Committee.

Responding to a recent court decision that the Certificate of Merit law does not apply to a non-licensed professional, House Bill 345 was introduced and heard on February 5th in the House Judiciary Committee. The only opposition to the bill came from the Maryland Bar Association and Maryland Association for Justice, who objected to a proposed requirement that the expert be a Maryland PE. At Delegate Luiz Simmons' (D-17) request, ACEC/MD has agreed to drop the Maryland PE requirement, but he is still expressing concern that the requirement to attain a certificate is too broad. Efforts are ongoing with Delegate Simmons to address his concerns, and we request that anyone residing in his district contact him to encourage his support for this legislation.

Finally, House Bill 1302 - Agreements to Defend or Pay the Cost of Defense - Void is scheduled for a hearing in the House Judiciary Committee on March 5th. This legislation would prohibit contracts for design, inspection or surveying services from including a "duty to defend" clause.

If your elected officials are on the Judiciary or Health & Government Operations Committees, please contact them and encourage their support on these important initiatives.

AIA BILLINGS INDEX ON THE INCREASE

After consecutive months of declining demand for design services, the Architecture Billings Index (ABI) showed a slight uptick for January. This key economic indicator of construction activity reflects approximately nine to twelve months of lead time between architecture billings and construction spending. The score increased from 48.5 in December to 50.4 in January. Anything over 50 indicates an increase in billings.
