PRESIDENT'S MESSAGE by Stu Taub, P.E.



With September's arrival, ACEC/MD activities are ramping up, committees are starting to meet and event planning is gearing up. We have a great group of folks from member firms who have volunteered to serve and to help, and I'd like to thank all of you! So what have we been doing lately?

In addition to attending regularly scheduled meetings, I was ACEC/MD's representative at the Maryland State Transportation Innovation Council (STIC) meeting on August 28 at SHA headquarters. This is a

group meeting with officials from FHWA, SHA, BCDOT, MTBMA, UMD and MdQl gathering to discuss FHWA Every Day Counts 4 (EDC), MD SHA STIC focus areas, SHA's proposal for their second STIC Incentive Grant, and MDQI's plans for a show-case of innovation in the private sector, academia, material suppliers, contractors and consultants. The grant program provides funds for innovative applications such as tablets for SHA construction inspectors and pavement density testing with ground-penetrating radar.

On September 18, Baltimore City Chair Neil Robinson, Past Chair Tony Mawry and I were ACEC/MD's representatives at a meeting with Director Pourciau to discuss Baltimore City's proposed process to procure A/E services on contracts for locally funded projects. Other representatives included folks from BCDOT, BCDPW, the Mayor's Office, COMTO, and WTS. Director Pourciau explained that she wanted to allow BCDOT staff to get better acquainted with consultants and to increase opportunities for small and disadvantaged businesses. The new procurement process involves a "Second-Tier" approach (an interview to get qualified and others for Task assignments). The forum allowed us to discuss concerns and ideas from both sides.

We closed out September with a quarterly ACEC/MD/MDOT SHA Partnering Meeting on the 27th, which is facilitated by Deputy Administrator Jason Ridgway and Bob Healy of RK&K, and includes SHA leadership, officials from MDTA and MTA and member firm representatives.

- MDOT TBUs are still working on developing consistent procedures and practices including fixed fee issue on task order contracts
- SHA will not require tracking of individual direct expense categories
- Use of Lump Sum in lieu of Cost plus Fixed Fee (further discussion needed)
- Cleaning up indemnification language in MDOT contracts
- Turnaround time for EOIs, and Technical and Price Proposals
- MTA will revise their Annual OH Adjustment procedure language
- A recent MPA EOI that was a cost competitive procurement
- MBE Sub Goals are determined by MDOT GOSBA based on disparity studies
- Establish Alternative Project Delivery and Quality workgroups
- Discussion on another PM Forum next Spring

ACEC/MD 2018-2019 SMART GOALS

ACEC/MD's Executive Committee, at their October 18th meeting approved Smart Goals for the new fiscal year. In additional to targeted initiatives from last year, this year's goals include an emphasis on further involvement of young professionals and the engagement of new member firms.

Membership Growth/Engagement

# YOUR MEMBERSHIP INVESTMENT AT WORK

In addition to advocacy at the state level, your membership dues play an important role in looking out for your interest at the federal level. While ACEC continuously advocates on your behalf in Congress, two important initiatives are underway with federal agencies.

First, ACEC is pushing back on a change that NAVFAC recently implemented to their solicitation template, specifically in Criterion 1 of the SF 330 that may have the effect of excluding examples of previous projects relevant to current and future competitions. Specifically, the new contract language included for Criterion 1 includes the following:

"All projects provided in the SF 330 must be completed by the actual office/branch/regional office/individual team member proposed to manage and perform work under this contract. Projects not meeting this requirement will be excluded from consideration in the evaluation."

In addition, ACEC's Federal Agencies and Procurement Advocacy Committee is joining forces with other professional associations to push back against the Federal Communications Commission's (FCC) interpretation of licensure requirements. Specifically in FCC Public Notice DA 18-887, there is the following reference to a "professional engineer," but without the requirement of licensure:

"While it is not necessary that the professional engineer certifying the network diagram have a Professional Engineer license, the certification should describe the professional engineer's qualifications such that the certifier's expertise is apparent."

Additionally, FCC Public Notice DA 18-186 states:

"For purposes of certification, a qualified engineer need not meet state professional licensing requirements, such as may be required for a licensed Professional Engineer, so long as the individual possesses the requisite technical knowledge, engineering training, and relevant experience to validate the accuracy of the submitted data."

Be sure to watch for updates from ACEC on these important issues.
