January marks the midpoint of ACEC/MD's fiscal year, so it seems a good point to look back a bit and then forward to the end of the fiscal year. Back in June, I mentioned several challenges that we as an industry would face in the coming year, which proved to be prescient as we have met many. Examples include: attrition in government agencies and meeting with incoming personnel; new

contract procurement language and terms; payment term revisions and other administrative issues. The good news is that we continue to meet with our government partners through our MDOT Liaison Committee, and I am encouraged by the collaboration that we've seen so far.

So, let's look back to our very successful ACEC/MD Holiday Party in early December where 211 attendees enjoyed food, drink and rampant networking at the Museum of Industry. December also saw several committee meetings, a MDOT Modal presentation and culminated in a General Membership meeting where newly elected ACEC Chair and CEO Linda Darr attended and presented her vision of ACEC moving forward. Looking forward, you will see planning and presenting programs and events like the Leadership Program, Legislative Action Day, Awards Banquet, PM Summit, Utilities Program, SBE/MBE Networking Program, Governmental Golf Outing, Environmental Forum, MDOT Business Units Program, and the 31st Annual Summer Conference at Nemacolin Woodlands Resort, June 26 - 28, 2019.

The year started off with initiating new workgroups (WGs), as discussed in the last two MDOT Partnering Committee meetings, to address issues and make recommendations to the Committee. These WGs include Contract Management, Alternative Project Delivery and Procurement/Finance. Work is progressing to set up agenda items and to schedule meetings before the next Partnering Committee meeting. At the last Partnering Committee meeting we also confirmed the topic for the next PM Summit to be held in May 2019. The topic is Water Resources involving

HHD and PRD, and the steering committee is getting geared up, so stay tuned. The Business Finance WG had a productive meeting with MDOT-SHA folks, which produced several important action items.

The Legislative Committee began reviewing proposed legislation from the Senate and House to flag any bills that may be of interest to our industry and to determine whether ACEC/MD should support, stay neutral or oppose the proposed legislation. This effort will continue until the Legislative Session is over. Folks this is no easy task, so I'd like to do a shout out to Legislative Committee Heidi Van Luven (AMT) and the committee. The committee went on to finalize the language for our 2019 ACEC/MD Legislative Business Agenda, which includes two proposed bills designed to strengthen contract language to bolster insurability and protect firms working on A/E contracts in Maryland. These agenda items include:

INDEMNITY – DUTY TO DEFEND REQUIREMENT
INCORPORATE NEGLIGENCE STANDARD

These items formed the main discussion points for our Legislative Action Day in Annapolis on January 22. We also included an item about Qualifications Based Selection (QBS) of A/E firms as a discussion item to keep it visible to legislators. Kudos to Chris Costello, our legislative counsel, for setting up sponsors Senator West/Delegate Parrot (Indemnity) and Senator Simonaire/Delegate Krebs (Negligence).



And speaking of our Legislative Action Day, I'd like to thank everyone (including our Leadership Program folks for Session III) who braved the bone-chilling weather and challenging traffic to participate in the visits with our elected officials. We had over 88 members spread over 12 teams that tirelessly worked the halls of the Senate and House office buildings to spread the word about ACEC/MD, our Legislative Agenda and, more importantly, to educate the newly elected officials on what our industry does each day for the citizens of Maryland. When the dust settled, and the smoke cleared, we had visited 43 elected officials and some of us attended the morning Senate and House sessions. After the visits, we all headed over to the Governor Calvert House for lunch with a nice turnout of 35 legislators and staffers and 100 ACEC/MD member firm participants. Thanks to everyone for assisting ACEC/MD in reaching its attendance goals for these important events. Afterward, Leadership Program folks participated in a "De-Brief" session with Chris Costello, to discuss the days visitations, and the Executive Committee held its January meeting.



January's Leadership Program Session Two (Characteristics of Leaders) got under way with facilitator Jim Marcotte presenting at the Engineers Club. After the session, participants were treated to a Happy Hour and some networking time.

Other committee meetings included, the County/Municipal Government Committee's meetings with Anne Arundel and Howard Counties. In addition to other county/municipal government meetings with client agencies; the Environmental; Public Relations; Utilities; SBE Round Table and Baltimore City Liaison Committees are scheduled in the Spring.

Many of you may be wondering what each of the emblems on ACEC/MD nametags represent, so here is what they are:

- The Crab indicates a personal contribution to the State PAC (CEPAC)
- The Maryland State Sticker indicates a firm's contribution to the State PAC (CEPAC)
- The American Flag represents a personal contribution to the Federal PAC (ACEC/PAC)
- The Minuteman Pin represents a firm's federal contribution to the Minuteman Fund

Name tags with all of these emblems show your's and your firm's full support of ACEC/MD and National.



Speaking of CEPAC support, did you know that only 30% of member firms consistently make donations to this important fund? You might be wondering what does CEPAC mean? It stands for the Consulting Engineers Political Action Committee, which is ACEC/MD's State Political Action Committee. Each year the committee works hard to represent your interests and provides a voice for industry issues in Annapolis with Maryland State Legislators. CEPAC contributes to and holds regular dialogue with Maryland State Senators and Delegates throughout the year. These discussions have promoted issues of direct benefit for every member firm and design professional including:

- Successful legislation to eliminate liquidated damages on MBE participation for State on-call AE contracts
- Defeat of attempted efforts to impose state tax on engineering professional services (two times)
- Establishment of a "Certificate of Merit" statute for lawsuits against professional engineers to eliminate frivolous suits
- Promote, educate and strengthen Qualifications Based Selection (QBS) for AE services
- For 2019, we are working to pass legislation eliminating the uninsurable "Duty to Defend" provision and a requirement that a "negligence standard" be included within State AE contracts

A new four-year election cycle has begun, and funding requirements have greatly increased as the cost of attending events has also increased. To meet this challenge, we established a Smart Goal to increase the CEPAC fund goal from \$25,000 to \$40,000. Your support is crucial! ACEC/MD is moving forward with a renewed effort for financial support and member engagement. The CEPAC accepts both company and individual contributions. We hope you will contribute and assist ACEC/MD in carrying the profession's message to our elected officials.

ACEC/MD HELPS LOCAL HIGH SCHOOL STUDENTS EXPLORE STEM CAREERS

BY ACEC/MD CAREER OUTREACH COMMITTEE CHAIR MIKE GALVIN (JMT)

ACEC/MD hosted a Maryland STEM Festival event on November 7 at the Engineers Club, providing students with opportunities to consider engineering/architecture careers.

Displays and presentations, led by professionals representing engineering/architecture firms from all over Maryland, demonstrated the exciting, varied, and rewarding careers available to students, and the contributions they might make in shaping the future. Volunteers from ACEC/MD member firms offered hands-on, mini-workshops in:

- Civil Engineering
- Traffic Engineering
- Planning
- Structural Engineering
- Architecture and Sustainable Infrastructure
- Highway Design
- Natural Resources
- Drainage and Stormwater Management
- Structural Applications
- Geographic Information Systems

Students from Digital Harbor High School, Baltimore Leadership School for Young Women and Coppin Academy High School (Baltimore City) and Chesapeake High School (Baltimore County) rotated in small groups through 10 stations, many of which included hands-on exercises.

Presenters answered questions that ranged from highly technical inquiries to the coursework and curriculum necessary to pursue an engineering career. Students enjoyed experimenting with different roadway slopes and curves using a test track, testing the effectiveness of different angles and shapes for structural practices using toothpicks, planning roadway improvements based on topographical and environmental constraints, learning how GIS is utilized across multiple disciplines, designing effective stormwater management features, and much more.

Stu Taub, ACEC/MD President stated, "STEM programs are vital to the continued success in our industry. These programs help young folks who have an interest in the sciences better understand what we do as an industry, and can help them on their way to a career in our industry."


