## PRESIDENT'S MESSAGE *by Alan Straus*



It is a busy season for ACEC/MD and I would be remiss if I didn't take another opportunity to thank all of the committee chairs and active participants. I have said many times, but it bears repeating: our success as an organization is due to the fantastic and committed work of our committees. Before I dive into the updates on ACEC/MD activities, I want to take this opportunity to congratulate Greg Slater for being confirmed as the new Maryland Department of Transportation

Secretary. We also wish Tim Smith congratulations for being named Acting Administrator of the MDOT-State Highway Administration.

The Maryland General Assembly is in session, and the Legislative Committee is busy with its review of many pieces of legislation. The committee divides the bills into subject areas and teams of individuals review each bill to determine its relevance to our industry and to achieving ACEC/MD's goals. The full committee meets weekly to review recommendations. Along with the review of the bills, the committee and others are working diligently in support of forwarding our annual legislative agenda. Our top legislative priority is passing legislation to achieve relief from unfair and uninsurable duties to indemnify and defend our clients against claims for which we are not the proximate cause. ACEC/MD representatives have been meeting with legislators individually and at our Annual Legislative Action Day on January 30th. We organized a visitation schedule to meet with dozens of legislators and their aides. Our CEPAC Committee has been integral in this effort, helping us gain access to influential legislators. We are hoping these touch points with many legislators, along with our targeted outreach, will lead to passage of Senate Bill 368 and its companion House Bill 681. We've also testified in both the Senate and House committees in support of these bills.

Our Legislative Committee also led a session at this year's MDQI conference on January 23rd. We summarized the legislative process in Maryland and how ACEC/MD works to forward important industry and business goals. Several of our committees continue their outreach and coordination with our clients, including meetings and presentations with various county representatives.
