EXECUTIVE DIRECTOR'S MESSAGE

#### DECEMBER GENERAL MEMBERSHIP MEETING FEATURES RECOGNITION OF NEWEST FELLOWS & DECARBONIZATION PRESENTATION

At the December General Membership Meeting, ACEC/MD was pleased to honor Past President Tony Frascarella (Century Engineering) and former MDOT Secretary and RK&K Principal Bill Hellmann as the newest Fellows, and retiring long-time Executive Director Jim Otradovec, who was recognized as an Honorary ACEC/MD Fellow. This honor recognizes individuals that have notably contributed to the advancement of consulting engineering in admin-

In addition to recognizing Tony, Bill and Jim for their impressive accomplishments, ACEC/MD was pleased to welcome Mark Lessans, Director of Regulatory & Environmental Affairs at Johnson Controls. Mr. Lessans discussed the overall trend of building electrification, which will have a dramatic effect on decarbonization. Moving away from fuel driven furnaces to heat pumps will be a major aspect of decarbonization. This electrification will target space heating, water heating and cooking. The ability to shift to heat pumps in colder climates will be key to reducing the impact of heating buildings. The

target is to optimize heating with heat pumps down to 5°F. Dual fuel systems will also be important to decarbonization.

Mr. Lessans also addressed the concept of beneficial electrification, which involves saving money over the long term, better grid management and reducing environmental impact. He noted that each choice cannot have a negative impact on one of the others. He also discussed policy driven electrification that is occurring in California, New York and New England. As examples, he cited how the use of natural gas has been disincentived in some California towns, which no longer allow gas pipes to be extended to buildings, and in Rochester, NY, where a rate hike was granted only due to an agreement to reduce gas hookups.

In summary, Mr. Lessans commented that future buildings will feature:

- Grid interactive efficiency
- Connectivity
- Smart attributes
- Flexibility

As you are probably aware, at the just concluded General Assembly Special Session, redistricting and consideration of the Governor's vetoes from the previous session took center stage. As expected, redistricting broke along party lines, with only Delegate Gabriel Acevero (D-Montgomery County) breaking party ranks. Also, as expected, overriding a number of Governor Hogan's vetoes was a priority. For your information, the following vetoes were overridden:

VETO OVERRIDES DOMINATE SPECIAL SESSION

(SB 9) - State Employees - Collective Bargaining - Applicability, Bargaining Processes, and Memorandums of Understanding: In collective bargaining, requires the Chancellor of the University System of Maryland (USM) to act on behalf of USM and its constituent institutions.

(HB 133/SB 30) - State Finance and Procurement - Appropriation Reductions (Board of Public Works Budget Reduction Clarification Act): Limits the Governor's authority to reduce specified appropriations for projects of \$10 million or more.

(HB 1091/SB 829) - State Procurement - Emergency and Expedited Procurements - Revisions and Reporting: Alters the requirements for emergency procurements to ensure MBE guidelines are being met.

(HB 933) - Anne Arundel County – Transfer Tax – Housing Trust Special Revenue Fund: Authorizes Anne Arundel County to increase the county transfer tax rate on properties valued at \$1 million or more.

(HB 894/SB 746) - Education – Community Colleges – Collective Bargaining: Establishes a collective bargaining process for local community college employees.

(HB 114/SB 199) - Transportation - Maryland Transit Administration Funding and MARC Rail Extension Study (Transit Safety and Investment Act): Requires increased operating spending, capital spending, and funding levels for the MTA.





#### VETO OVERRIDES DOMINATE SPECIAL SESSION (CONTINUED)

(HB 278) - Economic Development - Job Creation Tax Credit - Qualified Position and Revitalization Area: Alters the definition of "qualified position" for eligibility under the Job Creation Tax Credit Program.

(HB 319/SB 133) - Local Tax Relief for Working Families Act of 2021: Authorizes local governments to impose the county income tax on a bracket basis and requires all local governments to impose a minimum tax rate of 2.25%.

(HB 719) - Commercial Tenants - Personal Liability Clauses – Enforceability: Creates exceptions from personal liability clauses for businesses forced to cease operations due to pandemic-related gubernatorial orders.

(HB 836/SB 741) - COVID-19 Testing, Contact Tracing, and Vaccination Act of 2021: Requires the Maryland Department of Health to adopt and implement a two-year plan to respond to COVID-19 that addresses the disproportionate impact of the pandemic on underserved and minority communities.

(SB 202) - Correctional Services - Parole - Life Imprisonment: Increases the minimum time an inmate must serve before the opportunity of parole from 15 to 20 years. Removes the Governor from the process.

<u>Legislative Action - Not Considered for Veto Override</u>

(HB 372/SB 420) - Criminal Law – Drug Paraphernalia for Administration – Decriminalization: Changes statutory provisions related to "controlled paraphernalia" and alters penalties for offenses involving controlled and drug paraphernalia.

ACEC/MD ROLLS OUT 2022 LEGISLATIVE AGENDA

ACEC/MD officially kicked off the 2022 political season on November 18th at the organization's annual Legislative Breakfast. At this event, we were pleased to welcome featured speaker Mary D. Kane, President & CEO, Maryland Chamber of Commerce. Legislative Chair Dennis Simpson (AECOM) rolled out the ACEC/MD Legislative Business Agenda for the General Assembly Session, that convenes on January 12th, and CEPAC Chair Mike Blair (Johnson, Mirmiran & Thompson) encouraged firms and individuals to step up to the plate as we enter an election year. This year's agenda features modified Duty to Defend legislation that ties the duty to a court determined proximate cause of damages; targeted actions to address the dire straits of the Transportation Trust Fund; and educational information on the importance of using Qualifications Based Selection (QBS) when federal or state funds are used for design projects.

During her remarks, Ms. Kane commented that it is frustrating that Maryland is set up to be the perfect business state with features such as a highly educated workforce and close proximity to the nation's capital, but the reality is that the state's support for businesses pales in comparison with Virginia. She encouraged attendees to get involved by increasing political activism and spreading the word that we must do better or we will continue to see jobs flow out of state, as was recently evidenced with the location of a major Amazon facility in Virginia.

WHAT IS THE ISSUE?

As a matter of public policy, Maryland law currently voids some forms of broad-based indemnification clauses in contracts relating to construction-projects. Many contracts still require A/E firms and design professionals to indemnify and to assume a duty to defend various other parties with respect to claims caused by others but which the design professional has no legal liability.

Modification to Maryland statutory language is needed to ensure that A/E firms and design professionals are not required to pay for or assume uptront duty to defend claims caused by others, through no fault of the design professional, so that such risks are fairly borne by the responsible parties.

Legislative Action Required

Amend Section 5-401 of the Courts and Judicial Proceeding Article, Annotated Code of MD to void an uptront duty to defend and make indemnification unenforceable unless the design professional is the proximate cause of the injury/loss/damage. This would tairly assign liability to the responsible party.

WHY ARE THESE CHANGES IMPORTANT?

Professional Liability Insurance does not provide coverage for legal fees and costs incurred to defend other parties when there's no established negligence or legal liability of the insured design professional. (In other words, If is uninsurable).

- Small businesses including women and minority owned businesses could be bankupled by the current requirement.
- A design professional's responsibility for claims arising from A/E services should be considert with established legal principles for prefessional legally.
- Other states have recognized that limiting such tisis in the professional services contest is good public policy.

The modifications proposed in no way prevent an owner from recovering damages caused by the fault or negligence of a design professional.

QUALIFICATIONS BASED SELECTION (QBS)

Both federal and Maryland state procurements use a Qualifications Based Selection (QBS) method to procure professional design services for their projects.

WHAT IS THE ISSUE?

In the interest of public safety, both the federal and state government long ago mandated Qualifications Based Selection as the method to select architects and engineers. Federal and state funds are used by many local jurisdictions for infrastructure projects. Some of these jurisdictions are using a low bid system to select design services related to these initiatives.

Action Required

Encourage all local jurisdictions in Maryland to use the QBS process to select professional design firms when federal or State funds are used to pay for the services.

WHY ARE THESE CHANGES IMPORTANT?

- Qualifications Based Selection leads to higher quality services on public intrastructure projects. Quality professional engineering services are in the best interests of public safety.
- QBS ensures that the most qualified team is selected for the work.
- It provides for consideration of all teams based on past performance.
- Selecting the most qualified firm likely results in better design and construction savings.

WHY A LEGISLATIVE INTEREST?

- Important issue among Architectural/ Engineering Firms.
- State legislators can encourage local jurisdictions to advertise through a Q8S process.

Maryland's transportation system serves as the foundation of our entire economy. Moving people and vital goods and services is the indispensable responsibility of our transportation system, including our roads, bridges, highways, and transit facilities.

Congestion in Maryland is choking the transportation system, stifling commerce and negatively impacting our quality of life. Statistics show Baltimore ranked ninth for the most congested places in the nation in 2019, jumping two slots from 11th in 2018. The Greater Washington Metropolitan area combined is consistently in the Top-10 (often Top-5) of worst congestion in the nation based on these metrics.

The Transportation Trust Fund was established as a dedicated fund to support transportation needs in Maryland. Sources of revenue come from motor fuel taxes, vehicle titling taxes, registration and MVA fees, corporate income tax, operating revenues, sales and use tax on short-term vehicle rentals, bond proceeds, and Federal aid. The Fund supports operation and maintenance of State transportation systems, administration, debt service, and capital projects, as well as Maryland's portion of operating and capital subsidies for WMATA. A portion also goes to local transportation needs as capital grants.

Unfortunately, the Transportation Trust Fund does not have enough resources available to adequately maintain and expand our existing transportation system. We have reviewed many options for increasing transportation funding in Maryland and have come up with four proposals.

Proposal One - Transportation Commission Study

The first proposal is to ask the Governor to create a commission that will study transportation funding in Maryland. This commission would review and recommend possible revenue streams.

We can look to the past – the Blue Ribbon Commission was tasked in 2011 to make transportation recommendations under Governor O'Malley. They recommended \$870 million in new transportation investment, including a 15 cent increase in the gas tax, increased vehicle registration fees, and transit fare hikes.

We can also look to Pennsylvania, who recently created the Transportation Revenue Options Commission to find alternatives to the gasoline tax. Just last week, the Commission unveiled its proposed changes, which recommends phasing out the gas tax and replacing it over a five-year period with a variety of other fees and taxes. They estimate these changes will generate \$3.5 billion in the first phase, \$6.6 billion in the second phase, and \$11.5 billion in the third phase. The sources of revenue include the following:

- Establishing a miles-driven fee for every vehicle;
- Establishing a fee for every package delivered by companies like Amazon, FedEx, UPS, and local grocery stores and restaurants;
- Charging a per trip fee on ride sharing companies like Uber and Lyft;
- Increasing the car rental tax;

- · Establishing fees for electric vehicles; and
- Increasing vehicle registration fees.

Proposal Two - Gas Tax

The second proposal looks at two options regarding the gasoline tax – setting a floor on the gas tax and increasing the gas tax. The lack of a floor on gas prices contributes to a major structural problem in the funding formula, only to be exacerbated by the pandemic. This approach will ensure that even if the price of gas plummets, the tax will stay consistent whereby guaranteeing a certain amount in transportation funding each year.

We understand that passing a tax on gasoline during an election year presents challenges, but this option is an important one to revisit. By way of review, in 2013 the Maryland General Assembly passed House Bill 1515, which created an amendment to the existing "Gas Tax" with the intention of investing in and protecting Maryland's transportation infrastructure.

Unfortunately, this funding formula does not work in its present day form. There has been significant growth in electric vehicles and more fuel-efficient vehicles, leading to a devastating long-term steady decline in gasoline sales since 2005. Over the same period, highway and heavy construction costs have risen by approximately 50%. Additionally, the pandemic has caused a new shocking short-term decline in gasoline sales since April 2020.

We need to increase or restructure the gas tax to produce a consistent, sustainable flow of revenue that is sufficient to fund the engineering, construction, and maintenance of the State's roads, bridges, and highways.

Proposal Three - Fees for Electric Vehicles

Currently, Maryland does not place any type of fee or tax on electric and hybrid vehicles. There are almost 18,000 electric vehicles registered in Maryland. Surrounding states that do have a fee are Pennsylvania, Virginia, West Virginia, and North Carolina. We are recommending a similar approach to Pennsylvania who charges \$250 annually for commercial electric vehicles, \$175 annually for electric vehicles, and \$75 annually for hybrid vehicles.

Proposal Four - Regional Transportation Authorities

We recommend establishing regionally based funding authorities in the Baltimore area and the Washington Metro area to produce enough revenue to fund and support mass transportation projects and efforts in those regions. The Baltimore Region would incorporate Baltimore City, Baltimore County, Howard County, and Anne Arundel County. The Metro DC Region would cover Montgomery County, Prince George's County, Frederick County, and Charles County.

We can look to the models used in Virginia to determine the best types of revenue streams. They have three regional transportation authorities created over the last 20 years – the Northern Virginia Transportation Authority, the Central Virginia Transportation Authority, and the Hampton Roads Transportation Accountability Commission. Their primary functions are to develop and update regional transportation plans and conduct project planning, prioritization, and funding of transportation projects for counties and cities within each region. Some of the revenue streams include additional regional sales and use taxes, wholesale gas taxes, transient occupancy taxes, and fees on fuel efficient, alternative fuel, and electric vehicles.

Objective:

Create a commission that will study transportation funding in Maryland that will review and recommend possible new revenue streams for transportation projects.

Vehicle: Senate President Ferguson and Speaker Jones will establish the Commission.

 - Purpose- develop a comprehensive, strategic plan for addressing transportation funding needs in Maryland
 - Responsibilities:
 - Study and prepare a comprehensive list of potential revenue sources available for current and future transportation needs
 - Prepare a comprehensive funding plan
 - · Provide reports to the General Assembly
 - Composition (20 members):
 - 2 members of the Senate
 - 2 members of the House of Delegates
 - Secretary of Transportation or their representative
 - Secretary of Budget and Management or their representative
 - Secretary of Commerce or their representative
 - Secretary of Planning or their representative
 - 1 rep from WMATA
 - 1 rep from MTA
 - 1 rep from labor unions
 - 1 rep from environmental community, with a background in smart growth/sustainability
 - . 1 rep from the American Automobile Association (AAA)
 - · 1 rep from motor carrier industry
 - 2 reps from transportation industry construction/engineering
 - 2 reps from Maryland Association of Counties
 - 2 reps from Maryland Municipal League
 - Term of Commission
 - Commission will commence May 1, 2022 and terminate December 31, 2022.
 - Commission will provide an interim report August 1, 2022, and a final report November 1, 2022 to the General Assembly.
